Leveling Shim Kit 096



Introduction

The Leveling Shim Kit 096 supports the installation of the Snow/Ice Sensor 090/094 to sit flush with a slab surface which prevents standing water on top of the sensor surface.

The 096 is placed over the Snow / Ice Sensor Socket 091, this allow a height adjustment up to $\frac{1}{2}$ " to eliminate recession between the sensor and slab surfaces.

- Includes 3 shims: 2x¹/₈" and 1x¹/₄"
- 1/8", 1/4", 3/8", and 1/2" height adjustments
- · Constructed with brass
- 4 stainless steel screw sets

Mounting The Leveling Shim Kit



Mounting in the Socket 091:

- This step requires pulling either 65 feet or 208 feet of cable through the conduit.
- For new installations, before installing the 090/094, measure the recession using the black plastic cover installed to the height of finished slab surface.
- For existing installations, you must remove the 090/094 and fish the cable back through the conduit. Measure the recession from the height of the Snow/Ice Sensor 090 to finished slab surface. Determine which shims to be installed based upon the recession.
- Place the 1/8" shim on top of the socket to raise the sensor by 1/8".
- Place the 1/4" shim on top of the socket to raise the sensor by 1/4".

- Place 1x¹/₈" and 1x¹/₄" shims on top o the socket to raise the sensor by ³/₈".
- Place 2x1/8" and 1x1/4"shims on top of the socket to raise the sensor by 1/2".
- Fish back the sensor cable through the conduit.
- Fasten the sensor to the socket using the appropriate stainless steel screw set provided.
- Ensure there isn't debris on the sensor surface.

Limited Warranty The liability of tekmar[®] under this warranty is limited. The Purchaser, by taking receipt of any tekmar product ("Product"), acknowledges the terms of the Limited Warranty in effect at the time of such Product sale and acknowledges that it has read and understands same.

The tekmar Limited Warranty to the Purchaser on the Products sold hereunder is a manufacturer's pass-through warranty which the Purchaser is authorized to pass through to its customers. Under the Limited Warranty, each tekmar Product is warranted against defects in workmanship and materials if the Product is installed and used in compliance with tekmar's instructions, ordinary wear and tear excepted. The pass-through warranty period is for a period of twenty-four (24) months from the production date if the Product is not installed during that period, or twelve (12) months from the documented date of installation if installed within twenty-four (24) months from the production date.

The pass-through Limited Warranty applies only to those defective Products returned to tekmar during the warranty period. This Limited Warranty does not cover the cost of the parts or labor to remove or transport the defective Product, or to reinstall the repaired or replacement Product, all such costs and expenses being subject to Purchaser's agreement and warranty with its customers.

Any representations or warranties about the Products made by Purchaser to its customers which are different from or in excess of the tekmar Limited Warranty are the Purchaser's sole responsibility and obligation.
