

# tekmar tN4 Gateway Software License Agreement

These terms and conditions apply to the software made available to you (the "Licensee") by tekmar Control System Ltd. ("tekmar") upon acceptance of this license agreement (the "License").

THIS LICENSE IS A LEGAL AGREEMENT BETWEEN LICENSEE AND TEKMAR AND DEFINES WHAT LICENSEE MAY DO WITH THE SOFTWARE, AND WHAT LIMITATIONS EXIST ON WARRANTIES AND REMEDIES RELATED TO THE SOFTWARE. BY BREAKING THE SEAL ON THE PACKAGE OF THE PHYSICAL CD MEDIA LICENSEE BECOMES A PARTY TO, AND AGREES TO BE BOUND BY ALL THE TERMS AND CONDITIONS OF, THIS LICENSE AGREEMENT. IF, AFTER READING THIS LICENSE, LICENSEE DOES NOT ACCEPT OR AGREE TO THE TERMS AND CONDITIONS CONTAINED IN THIS LICENSE, LICENSEE SHALL NOT OPEN THE SEALED PACKAGE CONTAINING THE PHYSICAL CD MEDIA. IF LICENSEE DOES NOT ACCEPT THE TERMS AND CONDITIONS OF THIS LICENSE THEN LICENSEE SHALL RECEIVE A REFUND OF THE PURCHASE PRICE ONLY IF: 1) ALL OF THE CONTENTS OF THIS PACKAGE, INCLUDING ALL HARDWARE AND SOFTWARE PHYSICAL MEDIA ARE UNOPENED AND UNDAMAGED; AND 2) LICENSEE RETURNS ALL CONTENTS OF THIS PACKAGE, INCLUDING WITHOUT LIMITATION THE HARDWARE AND THE SOFTWARE, WITHIN 30 DAYS OF THE DATE OF DELIVERY (THE "ACCEPTANCE PERIOD"). TEKMAR RESERVES THE RIGHT TO CHARGE AN ADMINISTRATION FEE ON ALL REFUNDS AS MAY BE SET FROM TIME TO TIME.

## 1. Definitions

- (a) "Derivative Works" means any port, edit, adaptation, modification, enhancement or other alteration of, or to, the Source Code, or a portion thereof, by or for Licensee.
- (b) "Designated Equipment" means the tekmarNet4 Gateway product.
- (c) "Documentation" Documentation means printed or electronic documentation tekmar makes generally available to its licensees of the Software.
- (d) "Software" means (i) the executable code version of the tekmar tN4 Gateway software; and (ii) the human readable form of tekmar tN4 Gateway software; that is either shipped to the Licensee on a CD or is available to be downloaded from tekmar's website.
- (e) "Third Party Licensor" means a person or entity that grants a license to tekmar to redistribute that person's or entity's software or other intellectual property as part of or in connection with the Software.

## 2. Limited License Grant Subject to the conditions and under the terms of this license, TEKMAR hereby grants to Licensee a royalty-free, non-exclusive, non-transferable (except as defined herein), worldwide license for the term of this License to:

- (a) Derivative Works: (i) use, copy, modify, translate, compile and combine Source Code Software and Documentation to create Derivative Works for use with the Designated Equipment; and (ii) subject to Section 3, to distribute such Derivative Works; and
- (b) Software: Use the Software only with the Designated Equipment.

## 3. License Restrictions Without the express written permission of tekmar, Licensee shall not, and shall not permit any third party to:

- (a) Derivative Works: distribute, license or otherwise provide access to the Derivative Works except on a royalty-free basis;
- (b) Software: (i) subject to Section 3(a), sell, license, sublicense, publish, display, distribute, disseminate, assign, or otherwise transfer (whether by sale, exchange, lease, rent, gift, loan, or otherwise) the Software to a third party; (ii) subject to Section 5, alter, remove, or obscure any copyright, trade secret, patent, trademark, logo, proprietary and/or other legal notices on or in copies of the Software; or (iii) publish any results of benchmark tests run on the Software to a third party without tekmar's prior written consent.

## 4. Ownership and Title

- (a) Licensee acknowledges and agrees that the Software and all intellectual property rights therein and relating thereto (including, without limitation, all trade secrets, know-how and copyrighted material in any form) shall remain the exclusive property of tekmar and its Third Party Licensors including, without limitation, all algorithms, programs, whether in source code or object code form, procedures and documentation and is protected by Canadian copyright laws and international treaty provisions.
- (b) tekmar may, from time to time, distribute software or other intellectual property licensed to tekmar by a Third Party Licensor (the "Third Party IP") with or as part of the Software. Licensee acknowledges that Third Party IP is owned by Third Party Licensor. The rights and obligations of Licensee with respect to the Third Party IP are governed by Third Party Licensor license agreements provided by tekmar to Licensee as part of the Third Party IP license files and are attached hereto as Schedule A. By accepting the terms and conditions of this License, you also agree to be bound by the terms and conditions of the Third Party Licensor license agreements. Any license rights granted hereunder do not alter any rights and obligations you may have under a license agreement with a Third Party Licensor.
- (c) tekmar claims no interest in the Derivative Works of Licensee except for its ownership rights in and to the Software.
- (d) Except as expressly provided for in this License, this License does not transfer any intellectual property rights from one party to the other. tekmar reserves all rights in the Software not specifically granted herein.

**5. Notices and Copyright Should Licensee create a Derivative Work, Licensee shall:**

- (a) include this License with the license or distribution of any such Derivative Works;
- (b) preserve and reproduce such copyright, limited warranty and restrictive use notices of tekmar and its Third Party Licensors contained in the Software in the same form and location as in the Software; and
- (c) shall remove the tekmar name, trademark and logos from all generated web pages and any applicable source code thereof.

**6. Trade-marks and Logos Licensee shall not use or have any rights in any trade-name, trade-mark, or logo of tekmar, including without limitation tekmar®, tekmarcontrols.com®, tekmar Net® trade-marks any respective logos.**

**7. Limited Warranty** tekmar warrants that the physical media on the CD containing the Software, if applicable, is free from defects in materials and workmanship under normal use and service for a period of thirty (30) days (the "Return Period") from the date of delivery to Licensee. If such a defect exists within the Return Period, Licensee may return within ten (10) days following the expiry of the Return Period the entire package, including packaging, postage prepaid with a copy of the packing slip to tekmar and permanently delete and destroy all copies of the Software and certify such deletion and destruction to tekmar by written or electronic communication. tekmar, at its option, shall replace the CD media, however, if failure of the media is the result of accident, abuse, or misapplication, then in which case tekmar shall have no responsibility whatsoever to refund the purchase price or replace the CD media. In the event of replacement of the media, the replacement media will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is the longer. Except as set out in Section 9 hereof, this remedy is Licensee's exclusive remedy for a breach of warranty, and is tekmar's (or any of its affiliated corporations and their respective directors, officers, employees or shareholders) entire liability and only warranty made with respect to the Software.

**8. Any claims made by Licensee for the breach of a warranty, shall be made in writing and delivered to tekmar at the address set forth herein, and Licensee shall provide tekmar a reproducible test case, if applicable, demonstrating the breach of warranty.**

**9. Source Code and Software Disclaimer** OTHER THAN AS EXPRESSLY SET OUT HEREIN AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAWS, THE SOFTWARE IS PROVIDED "AS IS" WITHOUT ANY WARRANTY OR CONDITION OF ANY KIND, EITHER EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OR CONDITIONS THAT THE SOFTWARE IS FREE OF DEFECTS OR WARRANTIES AND CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY TEKMAR, ITS DEALERS OR DISTRIBUTORS, SHALL CREATE A WARRANTY OR IN ANY WAY INCREASE THE SCOPE OF THIS WARRANTY. LICENSEE ASSUMES THE ENTIRE RISK AS TO THE USE AND PERFORMANCE OF THE SOFTWARE IN TERMS OF CORRECTNESS, ACCURACY, RELIABILITY, CURRENCY, OR OTHERWISE. SOFTWARE PROVIDED BY THIRD PARTY LICENSORS IS SUBJECT TO THE DISCLAIMER SET FORTH IN SECTION 10.

**10. Third Party IP Warranty Disclaimer** UNLESS EXPRESSLY STATED OTHERWISE IN A THIRD PARTY LICENSOR'S LICENSE AGREEMENT, THE THIRD PARTY IP IS PROVIDED "AS IS". NEITHER TEKMAR NOR ITS THIRD PARTY LICENSORS MAKE ANY WARRANTIES, EXPRESS OR IMPLIED, CONTRACTUAL OR STATUTORY, PERTAINING TO THE THIRD PARTY IP, INCLUDING BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT. NEITHER TEKMAR NOR ITS THIRD PARTY LICENSORS WARRANT THAT THE USE OF THE THIRD PARTY IP WILL BE UNINTERRUPTED OR ERROR FREE OR THAT ALL NONMATERIAL DEFICIENCIES OR ERRORS ARE CAPABLE OF BEING CORRECTED. IN LIGHT OF ANY INCONSISTENCY OR CONFLICT BETWEEN THIS SECTION AND THE PROVISIONS SET FORTH IN A THIRD PARTY LICENSOR'S LICENSE AGREEMENT, THE PROVISIONS OF THE THIRD PARTY LICENSOR'S LICENSE AGREEMENT SHALL PREVAIL.

**11. Limitation of Liability** IN NO EVENT SHALL TEKMAR AND ITS AFFILIATES, AGENTS, THIRD PARTY LICENSORS, SUBCONTRACTORS AND THE RESPECTIVE DIRECTORS, OFFICERS AND EMPLOYEES OF THE FOREGOING BE LIABLE TO LICENSEE OR ANY OTHER PERSON FOR ANY DIRECT, INDIRECT, SPECIAL, OR CONSEQUENTIAL OR INCIDENTAL DAMAGES (INCLUDING WITHOUT LIMITATION, DAMAGES FOR LOSS OF REVENUES OR PROFITS, BUSINESS INTERRUPTION, TESTING INTERRUPTIONS, LOSS OF BUSINESS INFORMATION, AND THE LIKE) ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE, THE INSTALLATION OF THE SOFTWARE, THE TERMINATION OF THIS AGREEMENT, THE FAILURE OF EQUIPMENT RELATED TO LICENSEE'S COMPUTER OR DAMAGE TO LICENSEE'S COMPUTER, SOFTWARE OR OTHER PROPERTY RESULTING FROM LICENSEE'S USE OF THE SOFTWARE, EVEN IF TEKMAR OR ITS AGENTS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE OR CLAIM, OR IT IS FORESEEABLE. IN LIGHT OF ANY INCONSISTENCY OR CONFLICT BETWEEN THIS SECTION AND THE PROVISIONS SET FORTH IN A THIRD PARTY LICENSOR'S LICENSE AGREEMENT, THE PROVISIONS OF THE THIRD PARTY LICENSOR'S LICENSE AGREEMENT SHALL PREVAIL.

**12. BECAUSE SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES, THE ABOVE LIMITATION MAY NOT APPLY TO LICENSEE.**

**13. Licensee Indemnity** The Licensee agrees to indemnify and hold tekmar and its officers, directors, shareholders, employees and agents harmless from and against any loss, liability, cost, expense or damage (including reasonable legal fees) arising directly or indirectly out of any claim, suit action or judgment brought against tekmar related to (a) any Derivative Works created by or for Licensee (which Derivative Works are created solely at the risk of the Licensee); and (b) any act or omission by Licensee relating to the Software contrary to the terms of this License, including but not limited to the provision by Licensee of any products or services, any representations, warranties or covenants made by Licensee, any failure by Licensee to comply with any of the terms of this License.

**14. Termination** This License is effective until terminated in accordance with the terms of this License. This License will terminate automatically without notice from tekmar if, in its sole discretion, tekmar determines that Licensee has failed to comply with any provision of this License or if Licensee ceases to carry on business, becomes bankrupt or insolvent or makes an assignment or bulk sale of its assets or proposes a compromise or arrangement to its creditors. Upon termination of this License, Licensee shall, at tekmar's option,

return all copies of the Software or destroy all copies of the Software and shall provide tekmar with a certificate signed by an officer of Licensee verifying such destruction. Licensee may terminate this License at any time by contacting tekmar and provide tekmar with a certificate signed by an officer of Licensee verifying that such copies have been destroyed.

**15. Survival** Notwithstanding any termination of this Agreement, Sections 2(a), 3(a), 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 and 16 shall survive termination of this Agreement. All other rights and licenses granted hereunder will cease upon termination.

**16. Governing Law** This agreement is governed by the laws of the Province of British Columbia. Each of the parties hereto irrevocably attorns to the exclusive jurisdiction of the courts of the Province of British Columbia and the laws of Canada applicable therein, without regard to conflicts of laws principles. Licensee agrees that any claim or action brought by the Licensee shall be commenced in the courts of the Province of British Columbia. The parties agree that the United Nations Convention on Contracts for the International Sale of Goods does not apply to this agreement.

**17. Language** The parties have expressly required that this agreement and all documents and notices relating to this agreement be drafted in the English language. Les parties ont expressément exigé que la présente convention et tous les autres contrats, documents ou avis qui y sont afférents soient rédigés en langue anglaise.

**18. Severability** If any of the above provisions are held to be in violation of applicable law, void, or unenforceable in any jurisdiction, then such provisions are herewith waived to the extent necessary for the License to be otherwise enforceable in such jurisdiction. However, if in tekmar's opinion deletion of any provisions of the License by operation of this paragraph unreasonably compromises the rights or increase the liabilities of tekmar or its licensors, tekmar reserves the right to terminate the License and refund the fee paid by Licensee, if any, as Licensee's sole and exclusive remedy.
